The meeting was called to order by the Booster President, Kevin McElheney at 7:37 pm.

1. Minutes from last month's meeting were distributed. No amendments. Mary Redman made a motion to pass the minutes, Sandy Gatten second it. All were in favor, the meeting minutes were passed.
2. Treasurer's Report: In the main checking account we have \$13465.94 with no outstanding bills to pay at this time. The Student Savings account currently has \$10491.24. Bills that were recently paid were the second payment for the Spring Trip, 9,900.00, MBM Sodexo Transfer, 524.50 and 2012.57 for the Banquet. We will get a check from MBM to cover their portion.
