WCHS Raider Band Boosters Meeting Minutes

August 14, 2019

1. Meeting called to order at 7:45 pm by President Kevin McElheny
2. Approve July minutes.
  - a. Motion to pass the minutes by Michael Derosiers, second by Mary Redman, all in favor.
  - b. Minutes passed.
3. Treasurer's report. All treasurer information and materials have been given to Michelle Barnes, the new treasurer. All accounts remain the same except for the main checking which has approximately \$ 32,000. All camp instructor, choreography and music writing has been paid for. We still have the expense from Jackson's Mills to pay for.
4. Concession Stand.
  - a. Concession stand sign ups have been made and several parents have already signed up to either work or bring in items. Parents can email or call Jennifer Gumbarevic to sign up. We need approximately 10 parents per home game. Jennifer checked on the concession stand and it was unorganized. The floor looked good and seemed to have been cleaned and waxed. The counters were covered with Track and Soccer items. Our Coke cooler had cans of soda in it and had been being used with the lock still on the hasp. The hasp is now not able to keep the cooler secure. Jennifer will contact Rick Layton and see who was in charge during the Track season.
5. T-shirts
  - a. Currently we have 2 sponsors for the backs of the t-shirts. It was talked about finding 4 larger sponsors to cover the cost of the t-shirts however, Mr. Olisar spoke to Mr. Mason and we have to get the 25 sponsors as we did budget that. Jennifer will be working immediately on the shirts.
6. Email
  - a. The booster email was talked about. Jennifer is going to make a new email for the Secretary position. Kevin mentioned having Stacey monitor the band booster email account. This will be discussed further.
7. Fundraising.
  - a. Kevin is in charge of the Pepperoni Rolls from Jackson's Mills the orders are due on September 3 and will be delivered on September 19. This is right before a home game we can sell them at the concession stand. Last year Kevin believes that we sold 30 with no problem. It was discussed how many extra we should purchase for concession stand sales. Kevin mentioned at least the same amount as last year, perhaps even 50. Christy Barto suggested maybe purchasing 100. Being as the



pepperoni rolls are fresh and that is part of how well they sell, it was decided that we would purchase 50 extras. Next year, we will possibly purchase more depending on this year's sales in the concession stand.

- b. New York trip in the fall will be discussed at the next meeting.
  - c. Jill Barnhart is still in charge of the Sodexo fundraising. She has dates of football games to sign up for already. She is still looking for someone else to take over this fundraiser.
  - d. There were no other suggestions for fundraisers at this time.
8. Insurance: The insurance has been paid for. The trailer registration will arrive at the PO Box when it is due.
9. Pictures.
- a. It was unanimous that pictures being taken at home band camp was less stressful than when it is done at Jackson's Mills. MBM pictures went very well but the High School pictures weren't as smooth. The difference was that MBM had pictures taken as soon as they arrived. It was mentioned that maybe next year all pictures will be taken, and then practice will start.
10. Senior night banners will be the same as last year and were done at Direct Results. Jennifer will get the pictures to them as soon as they are available. Anyone with personal photos need to get them to Kevin as soon as possible so that he can put together a page for the Football program this year.
11. The shoe exchange went well during home band camp. We will continue to offer this.
12. Jackson's Mill band camp went well. Chaperones were pleased and there were no complaints.
13. Our next meeting is scheduled on October 4, 2019 at 7:30pm, in the High School band room.
